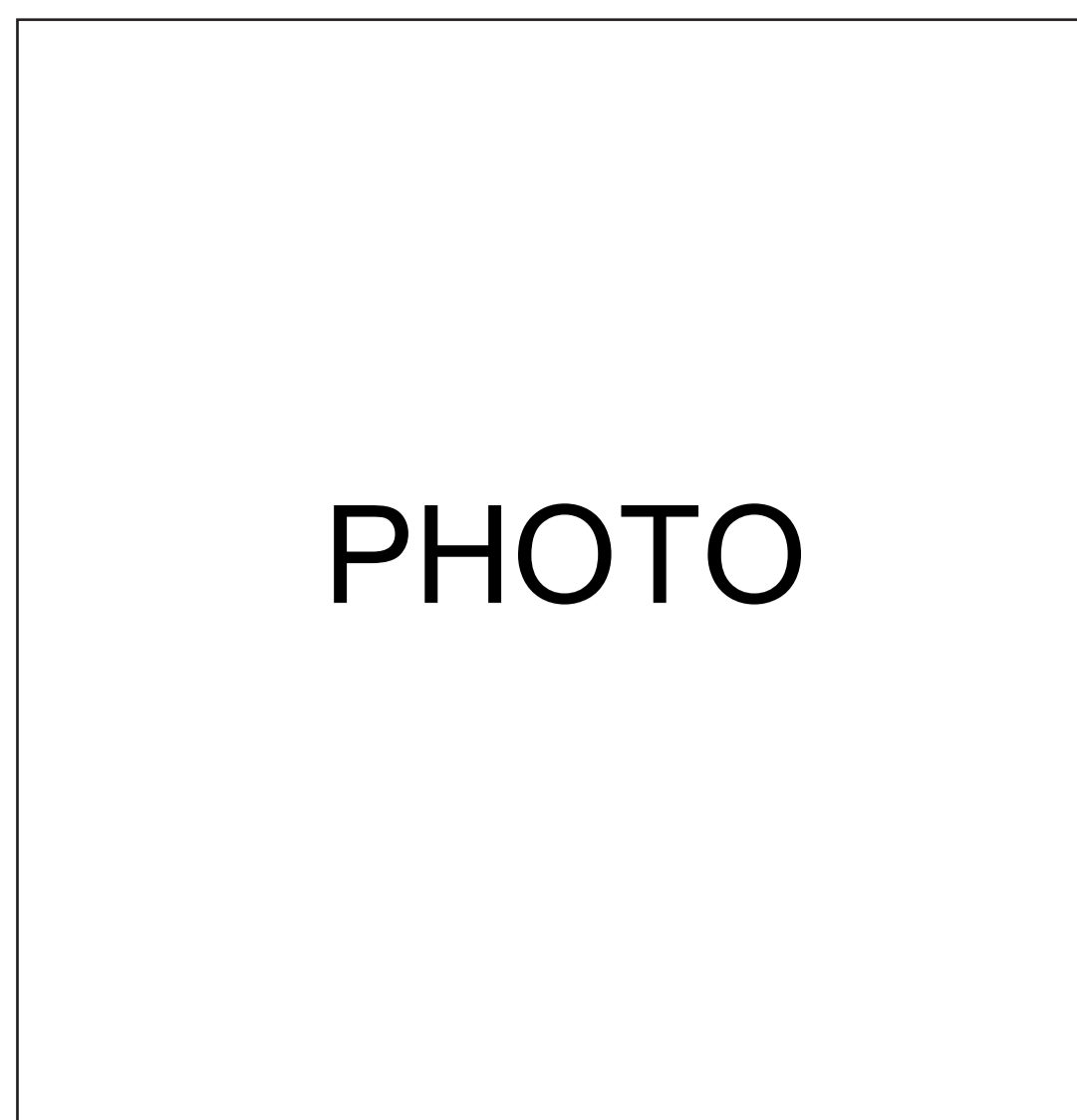

**DISCIPLINARY AGREEMENT(For both students and guardian)**

Applicant must follow the following rules upon enrolling DSS.

- The student will NOT indulge in any activities resulting in vandalism (causing damage to school property). If s/he causes the damage, accidentally or deliberately, we understand that our security deposit will be deducted for the repairment. If the repairment costs more than the security deposit, we are responsible to pay for the entire cost.
- The student will NOT be involved in plagiarism (copying homework from others or cheating during exams). If s/he plagiarizes in school, s/he will get no grade for the work.
- The student will always be punctual or all events. If s/he is not punctual, this may result in bad grades or stop him/her from going to a higher grade.
- The student will NOT attempt to bring any unauthorized materials such as a mobile phone or a laptop, unless and until approved by the school authority for special occasions.
- The student will NEVER be involved in organizing or participating in any group activities other than the one approved by the school.
- The student will abide by the rules and regulations of the school.
- We understand that Deerwalk Sifal School holds a special right to change the rules and regulations any time, and we are responsible to follow them as long as my child is a member of the school.
- We fully understand that Deerwalk Sifal School holds a right to take any level of disciplinary actions, including expulsion if it is deemed necessary for any kind of conflicts or disputes caused by either a student or guardian.
